

International Student Financial Guarantee

All three sections of this form must be completed. This form must be accompanied by a bank statement or bank letter sealed in an envelope by the sponsor's banking institution. Financial sponsorship documents submitted must be original or official received via mail. These documents will not be accepted via fax or email.

United States Immigration and Naturalization Service (INS) regulations require documentation that sufficient financial resources are available to meet a student's prospective educational and living expenses while in the U.S. Therefore, Oklahoma Panhandle State University requires a guarantee of financial resources from each applicant who expects to obtain or maintain Student (F-1) status. Applicants are required to submit financial documentation that equals or exceeds one full year of expenses, for the program of study they are interested in pursuing. This estimate is based upon 15 lower division credit hours each semester for undergraduate studies. A Certificate of Eligibility (I-20) will not be issued until this information is provided.

Scholarships available to international students at OPSU are very limited and students should not rely on scholarship funds or employment to finance their educational costs.

Students will not be permitted to enroll without full payment of their expenses upon arrival to OPSU. Please make arrangements in advance for money transfer to the student's OPSU account. Wire transfer instructions can be obtained by emailing international@opsu.edu.

If bank policies do not allow completion of this form, a separate bank letter or affidavit is an acceptable substitute. The letter should be on bank letterhead and include the following:

- Name of account holder
- Signed and stamped or sealed by a bank official
- Date account was opened
- Current account balance and date
- Monetary value must be converted to U.S. dollars
